Correspondence was received from the Tri-County Regional Planning Commission regarding an economic sustainability bus tour, Ingham County Treasurer regarding foreclosed properties, Daphney Kuschel regarding supporting her at the Ingham County Fair, Consumers Energy regarding energy performance, Granger regarding a recycling report, Ingham County Drain Commissioner regarding public hearings of apportionment.

Eldred stated he received correspondence from the Michigan Secretary of State that stated some legal descriptions needed to be corrected in the recent 425 agreement with the City of Leslie. Eldred stated the township attorney would make those corrections.

During comments the success of our first "Movie & Music at the Pavilion" was discussed. The possibility of a sledding hill on township property was also mentioned.
