Vickers reported the next cemetery board meeting will be June 19, 2015.

Eldred reported two township runs as well as hazmat training in the last month. The new ladder truck will arrive soon.

A written zoning report was presented.

Eldred reported the new building inspector has had seven inspections since he recently took over the position.

Eric Schertzing, Ingham County Treasurer, spoke to the board regarding three foreclosed properties in Leslie Township. Schertzing serves as the Foreclosing Governmental Unit for Ingham County. There was no interest from the board in acquiring any of the foreclosed properties but encouraged Schertzing to do some clean-up on the S. Main St. foreclosure. His willingness to work with Leslie Township was appreciated. There are three requests for conservation easements in Leslie Township. As there were unanswered questions it will be placed on the July agenda for consideration and hopefully more information can be obtained.

Andy Raymond from the Ingham County Conservation District spoke to the board regarding several issues including the annual Rayner Park Clean-up, tire clean-up held at the Ingham County Fairgrounds, grant opportunities for the conservation district and tributary contamination.

Motion Wade, support Vickers to contribute \$500 to the 1815 Michigan Survey Monument. Roll call vote, all ayes, motion carried.

Several 2015-2016 budget issues were discussed including landscaping, exterior doors, roads and a possible grant for a security system.

Motion Vickers, support Wade to approve the Leslie Township FOIA Procedures and Guidelines Policy. Roll call vote, all ayes, motion carried.

Motion Vickers, support Wade to approve the Leslie Township Public Summary of FOIA Procedures and Guidelines Policy. Roll call vote, all ayes, motion carried.

Motion Vickers, support Wade to approve the Leslie Township FOIA Request Detailed Cost Itemization Policy. Roll call vote, all ayes, motion carried.

Motion Wade, support Vickers to increase the assessor salary, zoning administrator salary and hourly wage for the deputy clerk, deputy treasurer, deputy supervisor, clerical, election chairperson and assistant assessor categories by 1.6%. This represents for cost of living increase for the State of Michigan for 2015. Roll call vote, all ayes, motion carried.

As always, the planning commission will accommodate the public depending on circumstances if they are unable to attend at 6:00 p.m. Roll call vote. Ayes: Wade, Vickers, Eldred and Feazel. Noes: Ward. Motion carried.

Eldred announced that the joint master plan and 425 agreement are on hold until the new city manager can be brought up to speed. Eldred also reported he has met with Enbridge and they continue to negociate road repair issues due to the pipeline installation.

Correspondence was received from the Ingham County Treasurer regarding the local purchase option regarding foreclosed upon properties in Leslie Township, Enbridge regarding a pipeline update and numerous drainage district notices from the Ingham County Drain Commission.
