Vickers reported the Woodlawn Cemetery Board is working on posting rules in the cemetery.

Chief Howe reported the fire department has been busy but running smoothly and all gear is in good condition. Howe gave a detailed report on the ISC Plating fire at 113 Covert St. Leslie Township was thanked for providing all the tools and training needed to fight fires. The new brush truck #743 was available for inspection by the Board and Guests.

A written zoning report was presented.

The firefighters present reported the fire department applied for a homeland security grant for a new \$855,000 ladder truck and equipment approximately a year ago and recently were notified they were awarded the grant. Motion Vickers, support Henney to proceed with the joint purchase of a ladder truck and to accept the Homeland Security Grant of \$815,000 with a 5% match of approximately \$42,800 (township would pay ½) and in addition the township would be responsible for ½ of the audit fee associated with the grant. Roll call vote, all ayes, motion carried.

Motion Henney, support Vickers to approve road closures for the Hallowed Half and Frightening 5K route (map attached) on October 25, 2014. Roll call vote, all ayes, motion carried. The Board was very supportive of the activity and several signed up as volunteers for the event.

Feazel reported that Sherry White has resigned from the janitorial position

because of family obligations. The Board was in general agreement that Deb Parmelee would add the cleaning of the offices and lower level of the township hall to her duties.

Feazel reported a 24.43% turnout for the primary election. In addition, the mock election that was held along with the primary was very successful and well received.

Correspondence was received from Granger regarding the recycling report and the Ingham County Road Department regarding the intersection of Hawley and Scofield Rds.

Vickers reported Gus Macker, the recreation survey summary, pool closure and softball were discussed at the Parks and Recreation meeting she attended.

Eldred reported he plans to meet with Brian Reed from the City of Leslie again regarding the Joint Master Plan but he feels attorney assistance may be needed. Eldred will report on his progress in September.

Feazel gave updates on the fall festival and the playground construction.
