The regular scheduled meeting of the Leslie Township Board of Trustees was called to order at 6:00 P.M. by Supervisor Henney in the Leslie Township Board Room. Henney led the Board and Guests in the Pledge of Allegiance.

During public comment Tim Howery of 2655 Ingalls Rd. addressed the board. In September he requested the township provide him with a dumpster on his newly acquired property adjacent to his principal residence. He felt the township had an obligation to have the parcel cleaned up as they had not required the previous owner to do so. Henney stated the township attorney felt providing Mr. Howery with a dumpster would set a precedent. Once again, no action was taken by the board.

Motion Pallottini, support Vickers to authorize Henney to sign a 3 year Municipal Service Agreement with the David Chapman Agency. Roll call vote, all ayes, motion carried.
