Mechanical and plumbing inspector Rex Simons plans to retire in September after almost forty years of service to Leslie Township. Eldred is working to find a replacement.

Spring Clean-up is scheduled for Saturday, May 12, 2018.

Feazel reported the Leslie Township Board of Review has adjourned for 2018.
