The regular scheduled meeting of the Leslie Township Board of Trustees was called to order at 6:00 P.M. by Supervisor Henney in the Leslie Township Pavilion. Henney led the Board and Guests in the Pledge of Allegiance.

Wade reported the next cemetery board meeting will be held on November 19, 2022.

Henney reported he had signed the contract for MMR to cover our residents with ambulance service along with the surrounding units of government. Henney would like to explore the possibility of the fire department becoming first responders.

In the zoning report Henney stated Firefly has been held up by an engineering issue and John Enos is currently working on a draft wind ordinance to present to the planning commission. In addition, a property on Kinneville Rd. has been flagged by the Ingham County Health Department for unsanitary living conditions.

Henney spoke with Ingham County Deputy William Bellinger regarding some issues on Eden Rd.

Ward reported the planning commission meeting on October 5, 2022 concentrated on wind ordinance revisions. They will next meet on November 2, 2022.

The 2021-22 audit report was presented to the Board. Drake Certified Public Accountants reported that the books were in good shape and they didn't have any recommendations for changes at this time.

Motion Wade, support May to direct Supervisor Henney to sign a proposal to purchase and install a 26kw air cooled back-up generator from Grand Bay Electric for a total cost of \$14,841.73. ARPA funds to be used to fund this improvement project. Roll call vote, all ayes, motion carried.

Correspondence was received from Wolverine Pipeline regarding pipeline safety.

During board comments the upcoming jail tour and clean-up days were discussed.
