Feazel reported the November 8, 2022 general election went smoothly.

May thanked the board for a great experience on the board of trustees and congratulated newly elected trustee Greg Gilliland and wished him the best.

During board comments Henney reported on the upcoming installation of the township hall generator, the bids for the Hull Rd. Trail will be opened tomorrow and the upcoming lighting project on the township path will soon be accepting bids.
