Wade reported the next meeting of the Woodlawn Cemetery Board is Thursday, January 18th at 11:00 a.m.

Chief DeKett reported on the activities of the fire department for the previous month.

Henney reported the next Planning Commission meeting will be held on Wednesday, February 7th at 6:00 p.m. The agenda will include special use permit reviews.

Motion Feazel, support Ward to adopt Ordinance 24.01-1 Zoning Ordinance Amendment - Wind as recommended by the Leslie Township Planning Commission. Roll call vote, all ayes, motion carried.

Motion Feazel, support Wade to adopt Ordinance 24.01-2 Zoning Ordinance Amendment - Solar as recommended by the Leslie Township Planning Commission with a change on page 12, section 11 to read No more than 2.5% (two- and one-half percent) 1% (one percent) of the total land within Leslie Township shall be approved for use as the project area for a Commercial Solar Energy System. Discussion included several reasons for this change including the preservation of farmland in Leslie Township, the state law preemption of noncompatible ordinances would include a one time payment of \$2,000 per megawatt hour of energy (minimum of \$100,000 per project) to be used for special projects in the township if the applicant uses the MPSC process to apply rather than at the local level. In addition, we have previously approved a solar project that will power 4,000 homes and we feel Leslie Township has done its share. Roll call vote, all ayes, motion carried.

Motion Wade, support Ward to adopt Resolution 23-24-06 Poverty Guidelines. Roll call vote, all ayes, motion carried.

Motion Ward, support Gilliland to adopt Resolution 23-24-07 Summer Tax Collection. Roll call vote, all ayes, motion carried.

Motion Gilliland, support Ward to adopt Resolution 23-24-08 Payment Reduction Program. Roll call vote, all ayes, motion carried.

During Board comments Leslie Township Clerk Assistant, Lynn Lankton, reported she has found a future deputy clerk and she has been hired as an election inspector in the meantime. Updates were also given on broadband, trail projects and the upcoming ad-hoc meeting.
