Haddrill went over the 2019-2020 audit report. He reported that the books were in good shape and that he didn't have any recommendations for changes at this time.

Motion Wade, support Feazel to hire Larry Craft as the Leslie Township Plumbing Inspector as of November 1, 2020 at the current rate. Roll call vote, all ayes, motion carried.

Vickers reported things have been busy at Woodlawn Cemetery with many funerals, hedge trimming and water main repairs.

Written reports from the fire department, sheriff department and zoning/building department were presented. It was reported the annual Halloween party sponsored by the fire department has been cancelled due to Covid-19 concerns. In addition a Cares Act Grant was accepted by the fire department to assist with firefighter hazzard pay.

The Board discussed and agreed that no hall rentals shall occur because of COVID-19 concerns until further notice. It will be placed on the April 2021 agenda for review at that time.

Eldred led a discussion on possible horse and buggy signs being placed in the township. Eldred will follow up with the Ingham County Road Department.

Motion Eldred, support Wade to allow the clerk to sign the MERS Defined Benefit Adoption Agreement Addendum with the vesting portion to include family leave. Roll call vote, all ayes, motion carried.

Motion Wade, support Vickers to accept a \$5,000. grant from the Center for Tech and Civic Life for safe and secure election administration. A plain clothes officer to assist at the election was discussed as a use for a portion of the grant. Roll call vote, all ayes, motion carried.

Motion Wade, support Feazel to increase the 2020-2021 budget 101-000-695 (Grant Proceeds In) \$2,500. & 101-101-970 (Twp. Bd. Capital Outlay) \$2,500. Roll Call vote, all ayes, motion carried.

Correspondence was received from the City of Leslie regarding a special use permit public hearing for Jim Byrum, IT Right regarding a pricing increase and an e-mail from June Pallottini regarding the Covert Special Use Permit.
